Welcoming the members present, Chairman reviewed the minutes of the last meeting as under:

I. REVIEW OF MINUTES OF MEETING HELD ON 7.2.2013

1. 1 **Annual Subscription** : Expressing his regret over delay in attending the meeting, Secretary read out the list of departments who have paid the subscription for the year 2012. According to the list, 23 departments have so far paid the annual subscription for the year 2012 totaling to Rs.34,400/- Chairman requested all Heads of Departments/Offices those who have not paid the subscription to take personal interest and see that the subscription is paid at the earliest. As all of you know this is the only income for the CGEWCC and any default on the part of any department will make it difficult to meet atleast a part of financial requirements in connection with Annual Day celebrations which is approximately more than Rs.1.25 lakhs.

1.2. **Allotment of GPRA to Coast Guard** : No response has been received from Director of Estates inspite of repeated reminders. The details as called for from the Residents Association also has not been received yet. Again the matter will be taken up with the appropriate authority.

1.3. **Availing of FSP/LTC.** It was informed that detailed letter had been sent to the DOP&T, who, in turn, have referred the matter to Ministry of Finance. Ministry of Finance has referred the matter to Ministry of Home Affairs stating that orders regarding FSP have been issued by MHA. The matter is now pending before MHA. We may wait for the outcome. If necessary reminder will be sent in due course..

1.4. **Launching of web site** : Chairman expressed his happiness over the launch of the web site and appreciated the efforts taken by Shri Goutham Gupta and his team of NIC for making it possible to launch the web site on the Annual Day on 27.2.2013, as planned.. It was observed that so far only 12 departments have furnished the requisite details which have been uploaded in the web site. All the remaining Departments may furnish the details urgently so that details of all the departments are available in the web site. A circular has also been sent to all departments in this regard.

1.5. **Celebration of Annual Day:** Chairman expressed his gratitude to one and all for making the Annual Day function a great success. He also extended his thanks to all those have participated in the Sports events, cultural programmes etc. He also recalled the services rendered by Shri D.Sathyamoorthy, Cultural & Sports Coordinator, Shri A.Justin, Secretary and Shri Kishen Singh. This year's Annual Day was a memorable one because our dream of having a web site of CGEWCC could be materialized with the help of all you especially Shri Goutham Gupta of NIC and his team. Sponsors viz. Syndicate Bank, Island Travels Pvt.Ltd. and BSNL deserved heartfelt thanks for sponsoring the Annual Day function. Due to one or other reasons, the Annual Day could not be conducted during 1st/2nd week of Feb.2013, as planned. All possible efforts will be made to conduct the Annual Day in the first/second week of February in next year.

II. NEW ITEMS

2.1. **Exemption of ISDA from income tax:** As discussed and decided in the previous meetings, the matter was taken up with the Commissioner of Income Tax, Kolkata as suggested by ITO, Port Blair and the same is being pursued through our Liaison office at Kolkata. It was informed by the office of the Commissioner of Income that due to financial year closing they are busy and the case will be put up during first week of April, 2013. .


2.2. **Appointment/Renewal of AMAs:** Out of 29 doctors appointed as AMAs for the year 2012-13, 27 Doctors have applied for renewal of their appointment as AMAs for further period of one year from 1.4.2013 to 31.3.2014. Besides, 4 more Doctors have now applied for fresh appointment which is being sent to the Sub-Committee for further action. On receipt of the Sub-Committee's recommendation, the necessary action will be taken for renewal/appointment of AMAs.

III. ANY OTHER POINTS :

3.1 Shri Shahid Iqbal of Provident Fund office said that he is so happy that the CGEWCC is conducting this type of meeting and thanked the Chairman and other members. He further said that their office web site can be connected with CGEWCC web site. Shri Goutham Gupta, NIC who was present in the meeting has agreed to do needful in the matter.

3.2. Shri Sudip Dutta of Indian Audit & Accounts Dept., Port Blair expressed that launching of such web do not serve any purpose in so far as there is no proper connectivity. In this regard Shri Sethupathi Raja, of BSNL informed that within the last 3 months BSNL has added some more events to improve the connectivity. He also added that speed of many of the customers have increased and any customer is having any specific type of complaint, they can contact BSNL and they will try to solve the issue.
