While welcoming the members present, the agenda points were taken up for discussion:

1. REVIEW OF MINUTES OF MEETING HELD ON 05.09.2014:

Annual Subscription: Chairman mentioned that only one Department viz. NIC has paid the annual subscription for the year 2014. All the Heads of Departments/Offices are once again requested to bestow their personal attention on the matter and ensure that the subscription due for 2013 as well as for the current year is paid to the Committee at the earliest possible. Dr. Kundu of CIARI pointed out that he is facing problem for collection of annual subscription from their staff as it was noticed by some of their staff that the subscription paid by some departments are not comparable to the staff strength of the department. He also requested the Committee to collect the staff details of each department so as to ensure maximum collection. Chairman mentioned that even though it may not be possible to collect cent percent subscription from all the departments, efforts will be made to ensure that all the officers and staff contribute so that the financial requirements of the Committee can be met to a certain extent. Secretary mentioned that details of staff in each department/Offices will be collected. Chairman also requested Shri Sathyamoorthy of ALHW to take steps to collect the subscription from the employees of ALHW. The rate of subscription from the employees of ALHW. The rate of subscription if furnished below:

a) Group "A" : Rs. 150/- per member per year
b) Group "B" : Rs. 100/- per member per year
c) Group "C" : Rs. 50/- per member per year

All the Departments are also requested to furnish staff strength of the respective departments for information and record.
