1. REVIEW OF MINUTES OF MEETING HELD ON 27.03.2015:

- 1.1 Annual Subscription: It was observed that inspite of repeated requests only 20 departments have paid the annual subscription for the year 2014. Chairman mentioned that the Committee has been taking lot of initiatives since its formation for the benefit of employees and family members. The major achievement is the construction of GPRA which has benefited lot of employees. Similarly, the Committee has been appointing a large number of AMAs for the benefit of employees and family members. The Committee has also been organizing sports and cultural activities. Since the Committee has no other source of income except annual subscription, all the Committee has no other source of income except annual subscription, all the departments may ensure that the subscription from all the employees are collected and sent to the Committee well in time.
- 1.2 Allotment of GPRA: No reply received from the Director of Estates, New Delhi.
- 1.3 <u>Web site</u>: It was noted that there has been no further improvements in the matter inspite of repeated requests. Chairman mentioned that Shri Goutham Gupta of NIC took special initiatives to launch the web site and he is always ready to upload the details of other departments, if provided to them. All the departments who have yet to provide the details may do so without any further delay.
- 1.4 <u>Publication of Souvenir</u>: The Sub-Committee Chairman, Shri T.N. Krishnamoorthi (Deputy Chief Engineer, ALHW) informed that only one department viz NIOT has sent article. Other departments have been once again requested to send articles so as to take further action in this regard.
- 1.5 Opening of Kendriva Bhandar: Shri T.N. Krishnamoorthi, Sub-Committee Chairman informed that the first letter sent to them has not been received and another letter has been issued.
- 1.6 Renewal of appointment of AMAs: The Committee was informed that appointment of 28 Doctors as AMAs in different disciplines have been renewed for further period of one year and letter has been sent to all.

2. <u>GENERAL:</u>

- 2.1 Farewell to Shri G. Rajan, Private Secretary to CE&A(ALHW): Chairman informed that Shri G. Rajan is retiring on superannuation on 31st May 2015. After discussions, members felt that Shri G. - 2.2 Shri Goutham Gupta of NIC informed that training is being organized at NIC on 29.4.2015 from 3 pm to 4 pm for implementation E-office and Biometric attendance system in the Central Govt. offices and he has requested to nominate one official as Nodal Officer from each department and also to sponsor 2-3 officials for the training. He has further informed that the training will be on continuous basis on every Friday for which circular will be uploaded in the web site of CGEWCC. It was also mentioned that necessary technical support will be provided by NIC for implementation of E-office and Biometric attendance system.
