At the outset the Chairman welcomed all the members present. Thereafter the agenda points were taken up for discussion as under.

1. Review of minutes of meeting held on 08.11.2013

1.1. Annual Subscription: Chairman informed that so far only 4 departments have paid the annual subscription for the year 2014. He also explained about the financial position and requested the departments those who have not paid the subscription to take urgent action to collect and remit the amount at the earliest possible. Secretary suggested that the subscription rate may be enhanced considering the financial liability. Accordingly, it was decided to enhance the rate of subscription as follows :-

1.2 Allotment of GPRA to Coast Guard: Detailed letter will be sent to Ministry of Urban Development intimating the latest position. Chairman also informed that he will try to contact the concerned officials in Ministry during his next tour to New Delhi.

Chairman read out a letter received from CPWD in reply to the letter sent by the Committee clarifying the position. As regards space for running of Anganwadi, Shri Edward mentioned that the Anganwadi is meant for the colony children and the CPWD is supposed to provide the space. CPWD may be requested to locate a suitable place at the earliest as possible. The Chairman further requested that the Executive Engineer, CPWD to attend the next meeting in order to discuss this matter in detail with clarity.

1.3 Availing of FSP/LTC: The matter is pending before Ministry of Home Affairs and they will be again reminded.

1.4 Web site: So far 14 departments have furnished the details and same have been uploaded in the web site. Chairman desired that all the remaining departments may also furnish the details to NIC without further delay. Vice-Chairman mentioned that in case of any department is having any problem in furnishing the details, they can contact the NIC.

1.5 Exemption of ISDA from income tax: The Sub-Committee may initiate action to publish the Souvenir during the ensuing Annual Day function.


2. NEW ITEMS:

2.1 **Conducting of Annual sports:** After discussions, it was decided to conduct the Annual Sports during the 2nd week of January, 2014. Chairman informed that participation in the Annual Sports events are not encouraging and only very few departments are participating. With view to ensuring more participation in all the activities of the Committee especially in the Annual Sports competition and Annual Day function, Chairman suggested that one person from each department may be given the responsibility who will coordinate with the staff and family members of the respective department and ensure that maximum number of staff and their family members should participate in the Sports competition, cultural programme and Annual Day function. Shri Edward of NSSO suggested that more programmes for the children may be organized which has been agreed. Mr. Kundu of CARI mentioned that examination of children may be taken into account while the fixing the date of Annual Day Sports. The Sports & Cultural Coordinator may discuss with all concerned and chalk out suitable programmes taking into consideration all the factors.

2.2 **Annual Day Celebration:** After the discussions, it was decided to conduct the Annual Day function during the last week of January/ first week of February, 2014. It was also decided to invite Hon'ble Lt. Governor as the Chief Guest and in case he is not able to come, Chief Secretary, A & N Administration may be invited as the Chief Guest.

3. **NEXT MEETING:** The next meeting will be held during the second week of December, 2013. The exact date and venue will be intimated in due course.
