At the outset the Secretary welcomed the members present in the meeting.

**1. REVIEW OF MINUTES OF MEETING HELD ON 24.7.2012**

1.1. **Water Supply to CPWD Colony:** Chairman informed that normal water supply to GPRA Complex will be possible only after raising the height of the Dhanikari Dam.

1.2. **Annual Subscription :** Chairman was of the view this point should not come for discussion in the next meeting. It was also noted that most of the departments have paid the subscription. All the remaining departments are requested to pay the subscription before the next meeting.

1.3. **Air travel by private Airlines by entitled officers:** In spite of repeated requests no response has been received. This will be pursued further. This point can also be discussed personally with the concerned officers by the officers during their official tour to New Delhi.

Chairman also mentioned that we have been pressing not to include ISDA for calculation income tax. He also said that in a recent seminar conducted by the Income

Tax authorities at Port Blair, one of our DDOs has raised this matter with supporting documents and insisted that this allowance should be exempted from the purview of income tax as has been done in the case of Defence personnel posted in these islands. The Income Tax officers were also of the view this allowance should be exempted from income-tax. It was also informed by the officials that the matter will be taken up by them with the appropriate authorities for an early decision.

1.4 **Allotment of GPRA to Cast Guard** : Based on the data collected, the matter has been taken up with the Director of Estates, New Delhi. If no response is received within another 10-20 days, any officers going to Delhi can personally discuss the matter with the concerned Officers besides sending reminder.

1.5 **Launching of Web site of CGEWCC** : Chairman expressed his happiness that atleast one department has responded. All are once again requested to take urgent action so that the long felt need of CGEWCC can be fulfilled.


### 3.3. Bidding farewell to Shri K.Sekar, Chairman:
