1.2 **Allotment of GPRA to Coast Guard** : It was informed that 2<sup>nd</sup> reminder has been sent to the Director of Estates. However, there is no response from them. Shri S.Edward of NSSO explained the background behind allotting the quarters to Coast Guard and difficulties faced by the CGE due to non-availability of quarters. 1.3 **Appointment of Area Welfare Officer:** The prescribed form is yet to be received from NSSO. Asst.,Director, NSSO informed that the form has been sent to their Headquarter for countersignature and once it is received back the same will be sent to the Committee.

2.1. **Holiday on account of Dusshera:** The Secretary mentioned that the holiday on account of Dusshera has been declared on 13<sup>th</sup> October, 2013 by the
