At the outset, Secretary expressed his thanks to CARI for sparing the Conference Hall for conducting the Coordination Committee meeting and thereafter he requested the members to introduce themselves and accordingly members introduced themselves.

Chairman mentioned that due to some preoccupations, this meeting had to be called on short notice and thanked Director, CARI for making arrangements for conducting the meeting at short notice.

The agenda points were taken up for discussion, as given below:

1.1. Review of the minutes of meeting held on 18.1.2013

1.1. Annual Subscription : It is seen that so far 22 departments have paid the subscription for the year 2012. Chairman requested all the Heads of Dept/Offices/Representatives to take personal interest in the matter and expedite payment of subscription at the earliest possible, as the lot of finance is required for organizing the Annual Day celebrations.

1.2. Allotment of GPRA to Coast Guard : No response has been received from the Director of Estates so far inspite of sending reminders. The matter will be taken up with Ministry of Urban Development after the details called for are received from the Residents Association.

1.3. Appointment of Area Welfare Officer : The form has been received from NSSO and sent to DOP&T for further action at their end.

1.4. Availing FSP/LTC: The draft letter prepared in this regard has been read out to the members by the Secretary and requested for suggestions of members. Dr.M.S.Kundu of CARI mentioned that Ministry of Defence have issued orders granting free Railway Warrant including sea passage in addition to the existing facility of LTC to Hometown/SPR/anywhere in India every year for the defence personnel serving in A & N Islands and copy of the order has been given to the Committee. Members felt that this point also should be added in the letter to be sent to DOP&T.

1.5 : Holiday on account of Dusshera: Necessary corrigendum has been issued and sent to all Circles. *o/n ead*

1.6. Launching of web site : Shri Vijay Nagu of NIC informed that so far 12 departments have furnished the details for uploading in the web site. Chairman informed that the web site can be launched with the data so far received on the Annual Day as planned and details yet to be received from other Departments can be uploaded in due course after launching of the web site. All the Departments who have not yet furnished details may take urgent action to furnish the details so that data of all the Central Govt. departments functioning in these islands can be viewed in a finger tip which will be beneficial for more interaction.

2. NEW ITEMS

2.1. Cultural programmes to be organized on Annual Day: Shri D.Sathyamoorthy, Sports & Cultural Coordinator mentioned that necessary circular has been issued in this regard and response so far is very poor. Chairman requested all the departments to encourage their staff to take special interest and send names of their staff and family members to Shri Kishen Singh at the earliest, as already intimated. Chairman also requested Director, CARI to arrange for presentation of few programmes from CARI, which he has agreed.

2.2. **Celebration of Annual Day:** After discussions, it was decided to celebrate Annual Day on **22.2.2013** in the Multipurpose Hall of ALHW, subject to the convenience of Chief Guest. It was also decided to invite the Chief Secretary, A & N Administration as Chief Guest on the occasion. Chairman requested the cooperation of one and all to make the function a grand success.

3. **NEXT MEETING** : It was decided to hold the next meeting during **2nd week of March, 2013 in the Conference of ALHW.** The exact date of meeting will be intimated in due course.
