At the outset, Shri Dam Roy, Director, CARI welcomed the members present at the Central Agricultural Research Institute. He expressed that he is very thankful to all

the members particularly, the Chairman, Vice-Chairman for conducting the meeting in the CARI.

Shri B.S. Jaswal, Vice-Chairman, presided over the meeting in the absence of Chairman. He expressed his thanks to the Chairman, Shri Bimal Sinha who is out of station to Delhi for some important meeting and all members of the Committee. Thereafter, he took up the agenda points for discussion as under:

I. Review of minutes of meeting held on 21.03.2014

1.1 **Annual Subscription** : Vice Chairman observed that this point is regularly coming for discussion. It is seen that some of the departments have paid the subscription. But still quite a good number of departments have not paid the annual subscription. He requested all the respective departments to arrange to pay the subscription. Secretary, informed that as decided in the last meeting, DO letter has been sent to all departments who have not paid the subscription. After issuing the DO letter, two departments viz. Dept. of Telecommunications and IGNOU have paid the subscription for the year 2013 as well as 2014.

1.2 **Allotment of GPRA**: It was observed that inspite of writing number of letters to various authorities including the Hon'ble Minister of Urban Development, no response has been received. It was decided to send one more reminder so that the new Govt. can take up the matter on urgent basis. Shri Haider of ASI stated that besides writing letters, efforts may please be made to discuss the issue with the concerned officials and try to solve the same at the earliest. Director, CARI suggested that this matter can also be taken up with the Hon'ble Lt. Governor for an early settlement.

1.3. **Availing of FSP /LTC** : The matter is still pending before Ministry of Home Affairs. Shri Kaladharan, NSSO requested that the matter may be pursued through the Liaison Office of ALHW, at New Delhi.

1.4. **Web site** : Secretary informed that as decided in the previous meeting, DO letter is being issued to all concerned. Vice-Chairman requested all the departments to kindly arrange to provide the details so that the same can be uploaded in the web site. The details such as main activities of the departments, employees details etc. can be prepared and sent to NIC who will arrange to upload the same. This will help to know each other well and also to interact more effectively in the peaceful regions of Andaman & Nicobar Islands.

1.5. **Exemption of ISDA from income tax**: No response has been received yet. It was informed that the Defence personnel working in these Islands are allowed exemption of ISDA from income tax. Director, CARI was of the view that whatever concession is given to the Defence personnel should also be extended to the Central Govt. employees. Shri Kaladharan requested that this matter may also be got pursued through the Liaison Office of ALHW at New Delhi with the concerned department.

1.6 **Publication of Souvenir:** Sub-Committee may initiate action on this from now itself so that the same can be published during the next Annual day function without any difficulty. Shri T.N. Krishnamoorthy, Sub-Committee Chairman requested all the departments to send some articles as already requested earlier at the earliest. Vice-Chairman informed that the departments can send good articles, songs, jokes etc., to the Sub-Committee Chairman for the early publication of Souvenir.

1.7 **Space for running of Anganwadi:** A reminder letter has been sent of Chief Engineer, CPWD, Chennai to do needful. There was some confusion over the matter and has been discussed in detail. It was clarified that the matter of space for sunning of Anganwadi was taken up with the Chief Engineer, CPWD, Chennai based on the request received from Child development Officer of A & N Administration through the Area similar type of Anganwadi Centre is running under Integrated Child Development Service (ICDS) Urban Project in INS Jarawa quarters, Minnie Bay quarter and other administrative vacant accommodation. As the matter is raised again and again in the meeting, we may await the reply from the Chief Engineer, CPWD. Shri Haider of ASI suggested that the facilities for recreation of staff members and their families may also be planned and considered in the GPRA Complex.

1.8 As regards housing scheme for Central Govt. employees, it was informed that Central Govt. Employees Housing Organization is implementing housing Scheme and they may be contacted for implementing such scheme in A & N Islands.

1.9 Shri Goutham Gupta of NIC has given the details called for opening a Kendriya Bahnder at Port Blair. The matter will be taken up with the concerned authorities.

II. **NEW ITEMS:**

2.1 **Renewal/Appointment of AMAs :** Secretary informed that 17 applications have been received for renewal of appointment as AMAs and necessary orders will be issued after completing the formalities. In addition, 4 fresh applications from the following have been received from the Hospital Dr. Debnath's Polyclinic & Diagnostic Centre in different department at Garacharma. After discussions, as this hospital is situated at Garacharma and there is o AMA in this locality, it was decided to consider the applications.

2.2 **Appointment of Auditor:** During the last year, AAO of ALHW had audited the accounts. It was decided to get the accounts audited by the same AAO.


III **GENERAL**
