1. REVIEW OF MINUTES OF MEETING HELD ON 17.10.2014:

1.1 **Annual Subscription:** Chairman informed that following departments have paid annual subscription for the year 2014.

All the Head of Departments/Offices who have not paid the subscription are once requested to take personal interest in this regard and ensure that annual subscription for the year 2014 is paid at the earliest possible. Annual Day function is to be planned now itself for which a sizable amount is required and the balance fund available with the Committee is very meagre and cooperation of all the departments are very much essential in organizing the annual day function. Hence the matter may please be given utmost priority.

1.2 **Allotment of GPRA:** It was informed that the Estate Manager-cum-Executive Engineer, CPWD had already taken up the matter with Deputy Director of Estates (Policy) in which he had pointed out that out of 88 Type III quarters 72 are occupied by Coast Guard personnel and only 16 are occupied by Civilian employees. He had also requested to review the allotment to Coast Guard and also to maintain separate seniority list for CGP and CGE. We may wait for their reply. In case no reply is forthcoming the matter will be taken up by the Committee with the appropriate authorities for an early solution to the long pending issue.

1.3. **FSP/LTC:** As decided in the last meeting, letter has been sent to Ministry of Home Affairs with kind attention to Joint Secretary (ANL) to clarify the matter. Reply awaited.

1.4. **Web site:** It is regret to note that inspite of repeated requests, the details called for has not been received from the remaining departments. All the departments are once again requested to send the details urgently to NIC who will in turn upload in the Committee's web site which will be easier to know the activities of various Central departments functioning in A & N Islands.

1.5 **Exemption of ISDA from income-tax:** As decided in the last meeting, letter has been sent to Ministry of Home Affairs with kind attention to Joint Secretary (ANL) to take up the matter with appropriate authority for an early solution in the matter. Reply awaited.

1.6 **Publication of Souvenir:** The Sub-Committee Chairman assured that the work will be started from next month.

1.7 **Opening of Kendriya Bhandar at Port Blair:** Sub-Committee may take further steps in the matter.

The following doctors have applied for fresh appointment as AMAs. After discussions, it was decided to refer their application to the Sub-Committee for further action.


