While welcoming the members present, chairman informed that he has to attend an urgent meeting convened by Secretary (Shipping), A & N Administration and he requested the secretary to continue the meeting.

Thereafter the agenda points were taken up for discussed as under:

1. REVIEW OF MINUTES OF MEETING HELD ON 27.03.2015:

1.1 Secretary informed that inspite of repeated requests even by D.O letters, the following departments have only paid the annual subscription for the year 2014. All the Departments who have not paid the subscription are once again requested to take personal interest and ensure that the subscription is paid at the earliest possible.

1.2 **Allotment of GPRA:** There is no response from the Director of Estates for the various letters written to him as well as Secretary to Govt. of India, Ministry of Urban Development. It is felt that there is no use of writing letters. If any of the higher officials from the Central Govt. departments visit Delhi, the matter can be pursued personally, if time permits.

1.3. **FSP/LTC:** This matter, inter-alia, was taken up with 7th Pay Commission on 4th Feb, 2015 by a delegation consisting of 7 members and presented a Memorandum and also made a power point presentation by Shri Balaji Prasad, DOT. Certain points covered in the Memorandum concerning these Islands were also discussed by the Members and the Chairman and other members were convinced that the employees should be allowed to avail FSP and LTC separately and it is hoped that this matter will be considered by the Pay commission. The payment of double HRA for the employees who are posted to outer islands from Port Blair and who are not able to get quarters was also discussed. The Committee gave a patient hearing to this issue and it is hoped that this issue will also get due consideration. The Committee expresses its gratitude to Shri Balaji Prasad for the efforts he has taken to present the Memorandum through power point.

1.4. **Exemption of ISDA from payment of income-tax:** This issue was also taken up with 7th Pay Commission and they informed that this is not coming under their purview and this has to be taken up with the Government.

1.5 **Web site:** It was mentioned that only 16 departments have furnished the details out of about 52 departments. It is once again requested to kindly take personal interest for sending the details to the NIC to enable and upload in the CGEWCC website.

1.6 **Publication of Souvenir:** Shri T.N. Krishnamoorthi, Sub-Committee Chairman, is on tour. However, Shri D. Satyamoorthy informed that few articles have been received in this connection. The Sub-Committee Chairman will be requested to follow up the matter.

1.7 **Opening of Kendriya Bhandar:** The position will be informed in the next meeting.

1.8 **Annual Day:** Secretary informed that the function was well organized and a large number of officials, family members and children attended the function held on 20th February 2015. He once again expressed the Committee's gratitude to all who are involved in the matter especially to Shri D. Satyamoorthy, the Cultural & Sports Coordinator for making arrangements for the cultural programme and also contributory dinner.

1.9 **Finalization of Memorandum to be submitted to 7th Pay Commission:** The committee once again expresses its gratitude to Shri. Balaji Prasad, Sub-Committee Chairman for sparing his valuable time for making the power point presentation.

2. **NEW ITEMS:**


