1. REVIEW OF MINUTES OF MEETING HELD ON 28.04.2015:

1.1 **Annual Subscription:** The annual subscription for the year 2014 has been received from 21 departments and remaining Departments have been requested to collect the same and remit. The major achievement is the construction of GPRA which has benefited lot of employees. Rs. 200/- per single person. Interested members may send their contribution to P.S. to Chairman on or before 31-08-2015.


